United States Marine Corps, distinguished himself by exceptionally meritorious service while responding to a shooting incident in Syria on 17 February 2018 that resulted in the injury of the Marine Sergeant of the Guard. rapid response to the shooting of a fellow Marine prevented (b)(3) 130b, (b)(6) further injury or death. He acted decisively to eliminate the threat to his comrade by firing several controlled shots at the person who shot his Sergeant of the Guard, and immediately removing the shooter's weapon. Once the shooter was no longer a provided medical care, applying a tourniquet and calling threat, (b)(3) 130b, (b)(6) for medical assistance. His actions were in keeping with the finest traditions of military service. The distinctive accomplishments of (b)(3) 130b, (b)(6) credit upon him, the Combined Joint Task Force, the United States Marine Corps, and the Department of Defense.
